On October 19, 2010 White House security recommended that I should talk to the Pentagon. The client went to the same gate as she did on October 27, 2010 as on Oct 20, 2010. She requested the phone number of the Pentagon and outlined her symptoms from July/Aug. 2010. On Oct 21, 2010 she called and spoke with officer Carpenter and he stated an officer would stop by her 324 Maryland Ave. NE Washington residence. On Oct 25, 2010 she again called Officer Carpenter and he stated someone would stop by. On Oct 26, 2010 she called the on duty officer and she told them she would be at the Pentagon at 9:00 am for she had not heard back.
